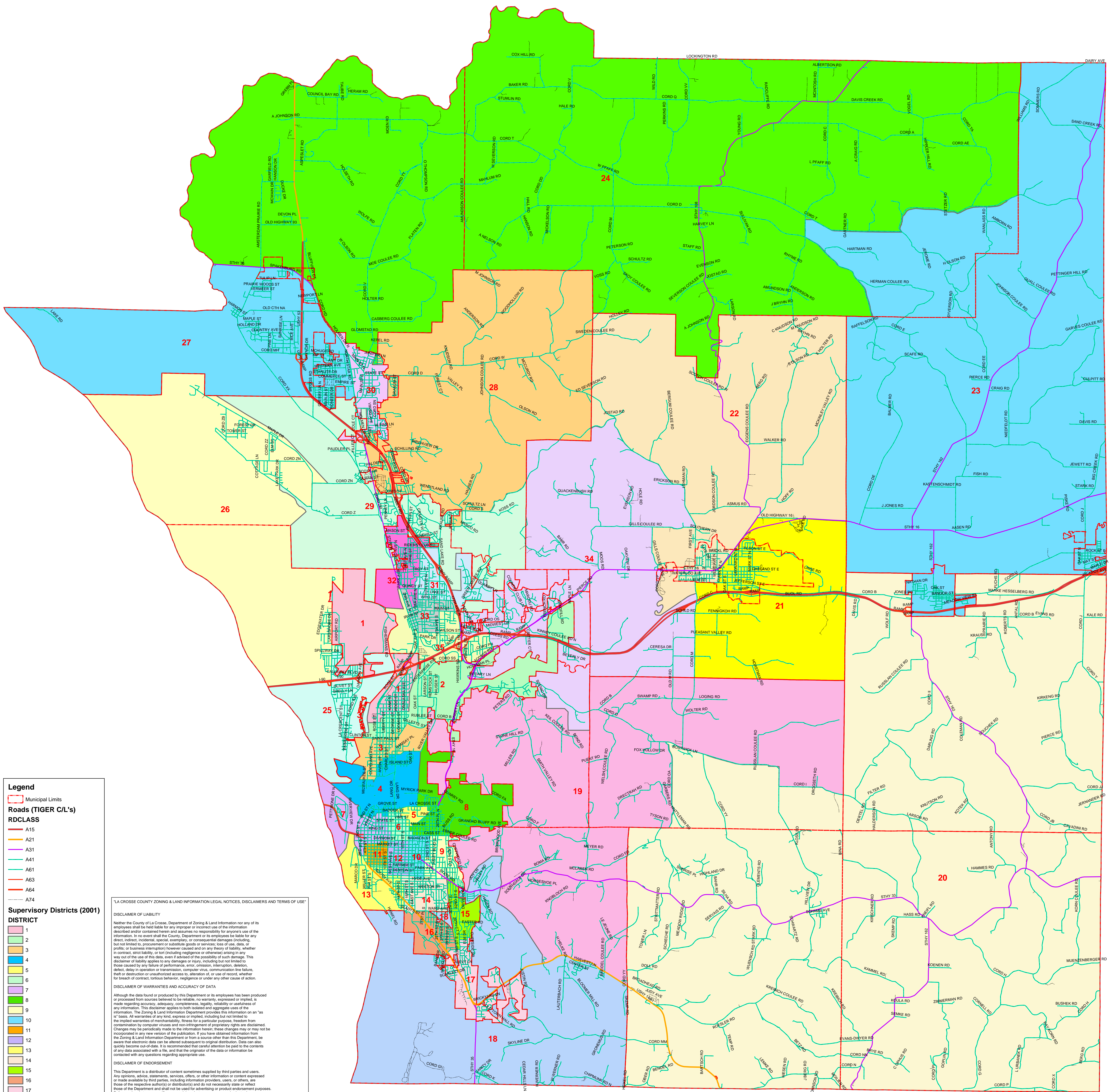


Fourth Amendment to La Crosse County Final Supervisory Districts Plan
